Dear Manitoba Pulse and or Soybean Farmer:

Thank you for your interest in becoming a director of Manitoba Pulse & Soybean Growers (MPSG). Nominations to fill four seats, each holding a three-year term, on MPSG's Board of Directors opens December 25 and will close on January 27, 2023.

Nominees for the position of director must meet the requirements as specified in MPSG's Bylaws. These requirements include that the nominee must be a member in good standing with our organization. A member in good standing is a Manitoba producer who has sold a pulse or soybean crop in the last two years and has not requested a check-off refund in the past fiscal year.

The board elections will take place during our AGM on February 15, 2023, at 8 am. The AGM will be held both in person in the Wellington Room A at the Victoria Inn Hotel and Convention Centre (1808 Wellington Avenue, Winnipeg), and virtually (registration information and the meeting link is available at www.cropconnectconference.ca). In the event of an election, candidates will be provided a maximum of two minutes to address eligible voters during the meeting. Directors take office at the commencement of the organizational meeting, held following the annual meeting.

MPSG is a non-profit, member-based corporation representing farmers in Manitoba who grow pulses including edible beans, peas, lentils, chickpeas, faba beans and soybeans. Directed and funded by producers, MPSG exists to advance all phases of the provincial pulse and soybean crop-growing industry.

- Maintain fiscal responsibility, including managing income, and approving and monitoring annual budgets
- Ensure transparency in all communication to members, and stakeholders
 - o Evaluate the association's work in relation to its strategic plan
 - Evaluate the work of the board of directors, ensuring continuous renewal of the board, and plan for the succession and diversity of the board

Responsibilities of Directors

- Act in the best interest of the pulse and soybean growers of Manitoba
- Be familiar with the organization's bylaws, policies and procedures, strategic plan and mission
- Operate in the best interest of the organization, not in self-interest or in the interest of a stakeholder group
- Respect confidentiality policies that pertain to membership and board discussions
- Keep informed about association's financial activity and legal obligations
- Attend board meetings regularly and arrive prepared for meetings
- Support board decisions once they have been voted on

Code of Conduct

MPSG has adopted the following code of conduct that all board members, agree to:

- Act honestly and in good faith with a view to the best interests of the association
- Exercise the care, diligence and skill that a reasonably prudent person would exercise in comparable circumstances

In addition, each director shall comply in fulfilling the following responsibilities:

- Managing conflicts of interest
- Harassment prevention
- Confidentiality
- Active participation

Time Commitment

Serving on the board of MPSG will require a commitment of personal time. Board meetings are held six times per year with additional meetings for committees on an as needed basis. Meetings are scheduled



during the day and will average 10 hours per quarter. Directors are expected to attend all meetings or give notification of not attending. In recognition of the board's considerable responsibilities and time spent attending meetings, MPSG provides each director with a small honorarium and meeting per diem.
